

In response to Item 2.1.9 of NUREG-0578, Duke Power Company is participating with other B&W owners in the Abnormal Transients Operating Guidelines (ATOG) Program. In a meeting held February 22, 1980 to discuss the program, Mr. T. H. Novak requested that specific program output be provided for review by the Staff. Therefore, drawings prepared to date for Arkansas Nuclear One, Unit 1 were transmitted to Mr. Novak by a letter dated April 16, 1980 from Mr. J. H. Taylor of B&W on behalf of the other B&W owners. Narrative material defining the methodology and scope of the program was also included. Although drawings will be prepared specifically for Oconee, the ANO-1 materials are representative and provide opportunity for Staff review of the program on a generic basis. The descriptive information and bounding assumptions apply equally to all the units.
