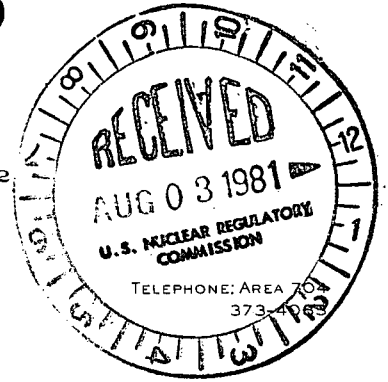


Subject: Qualification of Inspection, Examination, and Testing and Audit  
Personnel (Generic letter 81-01); Duke Power Company response

Dear Sir:

You requested, in your letter of May 4, 1981, commitments to meet the regulatory positions of Regulatory Guide 1.146 and Regulatory Positions 5, 6, 7, 8, and 10 of Regulatory Guide 1.58. Regulatory Guide 1.146 is acceptable as written, as are Regulatory Positions 5, 6, 7, and 10 of Regulatory Guide 1.58. Regulatory Position 8 of Regulatory Guide 1.58 states that Regulatory Guide 8.8 describes techniques, features and recommendations to maintain occupational exposures as low as reasonably achievable (ALARA). In place of Regulatory Guide 8.8, personnel at Duke Power Company facilities will use as guidance the Duke Power Company ALARA Manual, Administrative Policy Manual for Nuclear Stations, Radiography Safety Manual, and other directives which describe Duke ALARA practices.

The procedures for implementing these regulatory positions will be in place by September 30, 1981.
