Enclosed is Amendment No. 26 to your NRC Material License No. 24-32517-01 in accordance with your request.

Please note that significant changes to your license may appear in **bold** font, such as format changes resulting from requests you made and updates that we have implemented at this time.

In particular, please note that in Condition No. 12.B., we deleted the specific radionuclides in 10 CFR 35.300 that your authorized users are permitted to use, in favor of the simpler format that only refers to "10 CFR 35.300." At this time, we saw no reason to continue the previous format and the new format is more current and appears to give your authorized users the same authorizations as before.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC.

Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011.

While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
