

Gentlemen:

Pursuant to Oconee Nuclear Station Technical Specification 4.17.6(a), Duke Power Company is providing the following information concerning the Oconee Unit 1 steam generators. The steam generator plugging and repair for the Unit 1 End of Cycle 10 refueling outage was completed on October 23, 1987. The "A" OTSG had a total of eleven (11) tubes removed from service by plugging and a total of 271 tubes repaired by sleeving. The "B" OTSG had a total of sixty-eight (68) tubes removed from service by plugging and a total of 247 tubes repaired by sleeving.
