By letters dated February 26, 2003 (Serial No. 03-072) (ADAMS Accession No. ML030690393), February 28, 2006 (Serial No. 06-174) (ADAMS Accession No. ML060600281), and March 1, 2007 (Serial No. 07-0099) (ADAMS Accession No. ML070650263), Virginia Electric and Power Company (Dominion) submitted steam generator tube inspection reports for Surry Power Station.

The above reports satisfied the requirements of Technical Specification 5.6.7.b for North Anna Power Station Units 1 and 2, Technical Specification 4.19.F.b for Surry Power Station Units 1 and 2, Technical Specification 6.9.1.9 for Millstone Power Station Unit 2, and Technical Specification 6.9.1.7 for Millstone Power Station Unit 3, which required submittal of an Annual Steam Generator Inservice Inspection Summary Report to the NRC.
