Dear Sir:

In response to the February 16, 1976 Federal Register notice concerning 10CFR50.55a and NRC letter dated April 26, 1976, Duke Power conducted a review of the inservice inspection program requirements with regard to Oconee Nuclear Station.

The initial submittal for Oconee Unit 1 covering required Technical Specification revisions was provided on October 1, 1976 and was supplemented May 26, 1977 and April 27, 1978. Similarly, for Oconee Units 2 and 3, the initial submittal was made July 8, 1977 and supplemented September 21, 1977. Additionally, a letter providing supplemental information for all three units was provided March 6, 1978. The purpose of this letter is to provide a composite program description for Oconee Nuclear Station in one document. The program reflects the results of discussions with the NRC staff held during the site visit February 28 - March 1, 1979 as well as the details of the program provided in previous submittals. Proposed Technical Specifications related to the inservice inspection program will be provided by May 30, 1979.
