Pursuant to 10 CFR 32.16, we are providing the below transfer report for 2014.

Panasonic did not distribute projectors in 2014 that contain bulbs using Krypton 85 as covered in our E-Distribution License 29-27907-01E.

The use of bulbs containing Krypton 85 is phasing out in favor of newer bulb technology or alternative lamp source, eg. hybrid bulb and laser projector light source. Nonetheless, we would like to keep the current license. We are working on another product that relies on another isotope (Carbon 14) for use in radioactive exposure dosimetry. We have submitted an amendment request to NRC to include this material.

In accordance with 10 CFR 32.16, we are providing the attached Transfer Report.

TRANSFER REPORT FOR 2014

(a) Each person licensed under § 32.14 shall maintain records of all transfers of byproduct material and file a report with the Director of the Office of Nuclear Material Safety and Safeguards by an appropriate method listed in § 30.6(a) of this chapter, including in the address: ATTN: Document Control Desk/Exempt Distribution.

(1) The report must clearly identify the specific licensee submitting the report and include the license number of the specific licensee.

Answer: Panasonic Corporation of North America, E-Distribution License 29-27907-01E.

(2) The report must indicate that the products are transferred for use under § 30.15 of this chapter, giving the specific paragraph designation, or equivalent regulations of an Agreement State.

Answer: The products (projectors) are transferred to our California warehouse for which we maintain a Possession License # 7721-30. As stated above, there was 0 transfer and distribution of these products in 2014.

(b) The report must include the following information on products transferred to other persons for use under § 30.15 or equivalent regulations of an Agreement State:

(1) A description or identification of the type of each product and the model number(s), if applicable;

Answer: The products (projectors) contain Krypton 85 within the bulb. As stated above, there was 0 transfer and distribution of these products in 2014.

(2) For each radionuclide in each type of product and each model number, if applicable, the total quantity of the radionuclide; and

Answer: The bulb contains Krypton 85, maximum quantity of 5 nanocuries per bulb.

(3) The number of units of each type of product transferred during the reporting period by model number, if applicable.


