The purpose of this modification is to exercise option year 3, increase the Base and Exercised Options by \$141,409.32, from \$372,772.30 to \$514,181.62, and obligate funds in the amount of \$35,352.33, thereby increasing the total obligations from \$372,772.30 to \$408,124.63.
