Amendments to Indemnity Agreements

By application dated June 12, 1997, Duke Power Company advised the NRC that its corporate name had been changed to Duke Energy Corporation and sought amendments to the power reactor operating licenses for the Oconee, McGuire, and Catawba Nuclear Stations in the captioned dockets to reflect this change. The NRC issued amendments reflecting our new corporate name on August 22, 1997 for the Catawba Nuclear Station, Units 1 and 2 (TAC Nos. M98958 and M98959), on August 26, 1997 for the McGuire Nuclear Station, Units 1 and 2 (TAC Nos. M98960 and M98961), and on September 16, 1997 for the Oconee Nuclear Station, Units 1, 2, and 3 (TAC Nos. M98987, M98988, and M98989). It has come to our attention that we neglected to request conforming changes to Indemnity Agreements B-44, B-83 and B-100, respectively, to reflect this name change.
