By letter dated November 19, 1985, Duke Power Company (Duke) submitted proposed revisions to the Oconee Nuclear Station (ONS) Technical Specifications which were required to support the operation of Oconee Unit 1 at full rated power during Cycle 10. The proposed Amendments included a revision to specification 3.5.1.b (located on page 3.5-6).

Duke has determined that specification 3.5.2.1.b does not need to be revised in order to support the operation of Oconee Unit 1 at full rated power during Cycle 10. As such, Duke requests that the proposed revision to specification 3.5.2.1.b, as requested in my November 19, 1985 letter, be withdrawn from consideration during the review of the proposed amendments. Inasmuch as this is the only change on page 3.5-6, this page (3.5-6) should be deleted from the list of pages to be revised by the proposed amendment request.
