Gentlemen:

By letter dated March 15, 1988 pursuant to 10CFR50, Part 50.90, Duke Power Company (Duke) provided a supplement to an October 8, 1984 proposed amendment to the Oconee Nuclear Station (ONS) Facility Operating Licenses and revisions to the ONS Technical Specifications. The March 15, 1988 supplement included operability and surveillance requirements for Inadequate Core Cooling (ICC) instrumentation, as well as administrative changes.

Please find attached (Attachment 1) a further supplement to the October 8, 1984 amendment request. This supplement clarifies operability requirements for accident monitoring instrumentation found in Specification 3.5.6.2. Specifically, specification 3.5.6.2.a is clarified to be the Wide Range Containment Water Level Monitor. This supplement affects only page 3.5-44 of the March 15, 1988 amendment request supplement.

All other portions of the October 8, 1984 proposal and the August 27, 1985, September 19, 1986, and March 15, 1988 supplements including the No Significant Hazards Consideration Evaluation and Technical Justification will not be affected by this supplement.

Duke is providing a copy of this supplement to the South Carolina Department of Health and Environmental Control for review and, as appropriate, subsequent consultations with the staff.


