

By letter dated September 9, 1988, Duke Power provided a proposed license amendment that would delete the cycle-dependent core operating limits from the Technical Specifications. This proposal contained a Specification 6.9, Core Operating Limits Report.

Subsequent Duke review has determined that the parenthetical expression in specification 6.9.3 needs to be revised. Accordingly, the attached proposed revision is provided.

The previously provided No Significant Hazards Consideration remains valid. This letter supplements the previously proposed amendment request, as such no additional application fee is necessary.
