These amendments are necessary to implement the requirements of the Omnibus Budget Reconciliation Act of 1990, as amended, to recover approximately 90 percent of the U.S. Nuclear Regulatory Commission's Fiscal Year 2015 budget authority through fees.

The proposed rule is consistent with Commission fee policy decisions, does not constitute a significant question of policy, nor does it amend regulations contained in 10 CFR Parts 7, 8, or 9 Subpart C concerning matters of policy. I find that this rule is within the scope of my rulemaking authority and therefore I am proceeding to issue it.
