Dear Ms. Foster:

I am writing on behalf of Carson City Hospital, NRC license #21-16339-01. Recently, Carson City Hospital merged with Sparrow Health System of Lansing, MI. The merger took place on February 1, 2015. Sparrow Health System became the sole corporate owner. We wish to transfer control of the license to Sparrow Carson Hospital.

I am informing you of the merger and the name change from Carson City Hospital to Sparrow Carson Hospital. Although the hospital is now owned by Sparrow Health System, the local administration, and the radiation safety program will remain unchanged. I am attaching a letter from the local administration describing the merger.

We understand it will take some time to process the name change and trust that they will be able to continue their use of RAM under their old name until the process is completed.

There will be no change in the day-to-day operation in the use of radioactive materials. There are no anticipated changes in technologists, authorized users, or the Radiation Safety Officer.

As there will be no cease of operations, no decommission of facilities or transfer of radioactive sealed sources, wastes or any other transfer of byproduct material is planned.

All records and procedures of Carson City Hospital shall be maintained by Sparrow Carson Hospital. Sparrow Carson Hospital will honor all commitments and maintain all constraints made in the RAM license of Carson City Hospital.
