ESEP – Expedited seismic evaluation process

HF - high frequency

SFP – spent fuel pool

SPRA – seismic probabilistic risk assessment



# Significant R2.1 Seismic Review Progress

Seismic	
Hazard Reevaluation Reports Received	61/61 (100%)
Suitability of GMRS Hazard Issued	59/61 (97%)
Expedited Approach [ESEP] Received	33/34 (97%)
Expedited Approach Response Issued	21/33 (64%)
Hazard Staff Assessments Issued	32/61 (52%)



## **Seismic Hazard Review Updates**



### Seismic Hazard Review Updates

- More than half of the SAs for CEUS have been issued
- SAs for CEUS screen-out sites expected to be issued by March 31, 2016
- WUS hazard review are ongoing
  - RAIs have been issued to each licensee
  - SAs expected by Q3 2016
  - Target for hazard suitability letter is December 2015
- Final screening and prioritization determinations made (SPRA Reassessment letter - ADAMS Accession ML15194A015)



# **Expedited Seismic Evaluation Process reviews**



#### **ESEP** reviews

- Reviews nearing completion for all the CEUS sites
- ESEP response letters issued by December 2015
- WUS ESEP submittal expected in January 2016



## **Limited Scope Evaluations**



#### **HF** evaluations

- Staff issued the HF guidance endorsement letter Sept 17 (ADAMS Accession No. ML15218A569)
- HF evaluations for sites with limited exceedances expected by December 31, 2015
- High frequency submittal template development in Q1 2016
- HF evaluations for sites with moderate to high exceedances expected by December 31, 2016
- HF evaluations for sites no longer requiring an SPRA expected by August 31, 2017



#### **SFP Evaluations**

- NRC currently reviewing EPRI's white paper
- NRC endorsement of EPRI's white paper following comment resolution and formal submittal
- SFP evaluation for low hazard sites (<.8g) expected by December 31, 2016
- SFP evaluation for high hazard sites (>.8g) expected by December 31, 2017



## SPRA Reassessment / Revised Schedules

- Final determination documented in the letter (ML15194A015)
- Letter is in final concurrence
- Sets SPRA schedule for 20 sites
- Concludes SPRA for 13 sites are not warranted



### Seismic rulemaking guidance

- Staff currently reviewing draft NEI 12-06 Appendix H (ML15233A050)
- Staff provided comments on Appendix H (ML15273A267)
- Publication of Draft Guide (DG)

- Future public meetings to be planned for Paths 4 and 5
