Dear Sir or Madam:

Pursuant to Nuclear Regulatory Commission regulations in 10 C.F.R. Part 2, Subpart M, Patriot Coal Corporation ("Patriot") hereby provides notice that on October 28, 2015 Patriot Coal Corporation and its wholly-owned subsidiaries successfully completed the Chapter 11 restructuring process thus completing Patriot's Plan of Reorganization. Patriot has completed the transactions to sell most of Patriot's operating assets to Blackhawk Mining, LLC and to sell substantially all of its remaining assets and liabilities to an affiliate of Virginia Conservation Legacy Fund, Inc. ("VCLF"). Several of Patriot's affiliated companies with operations in West Virginia are NRC license holders and a complete list of these NRC licenses, including the names of successor companies, is provided below.
