

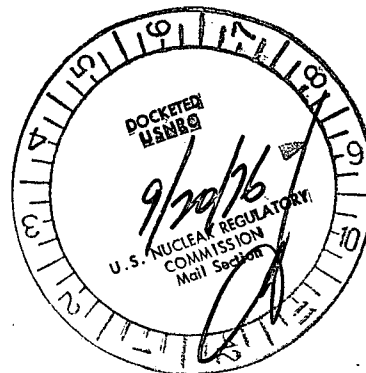
Dear Mr. Rusche:
