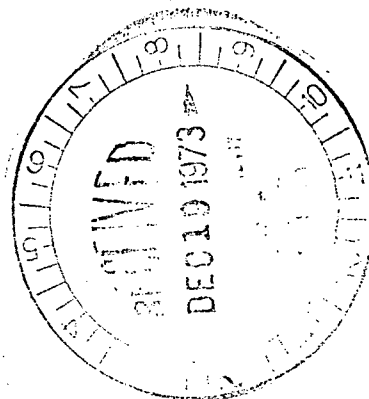

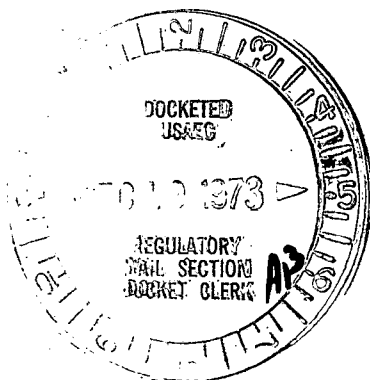

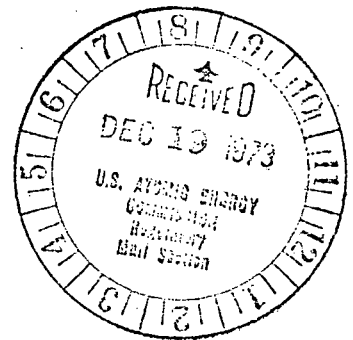

Transmitted herewith are sixty (60) copies of a Babcock & Wilcox PROPRIETARY report, BAW-1399, "Oconee 3 Fuel Densification Report".

This report together with Babcock & Wilcox PROPRIETARY Topical Report BAW-10054, Revision 2, present the specific results for the Oconee 3 cycle 1 fuel and support operation of this plant at rated power (2568 MWt).
