Dear Mr. Paulus:

I have learned that Clemson University Library has received inquiries about Duke Power Company's three reactors at the Oconee Nuclear Station, and especially about those reports which are required to be filed with the NRC and the Oconee Public Library. The Oconee library, which is in Walhalla, is nearly 20 miles from the Clemson academic community and even farther from those people in Anderson, Greenville and Atlanta who have needed to consult the reports.

Clemson University Library regularly receives Duke's annual reports on the Oconee Nuclear Station which include monthly maintenance reports, reportable occurrences, and shut-downs. Recently there has been an increased demand at the University Library for more current information than is presently available. Faculty and research personnel as well as students have found it so inconvenient to travel to Walhalla that we wonder whether current reports - monthly maintenance and abnormal/reportable occurrences - might not be filed here as well as in Walhalla. They would certainly be more readily available and more useful.

Mrs. Peggy Cover, Librarian in Charge, Science, Technology and Agricultural Services, Clemson University Library, states definitely that she thinks the University Library should receive these reports. If they are addressed to her she will be responsible for handling them in such a way that anyone interested will have access to them.

Should you not be in a position to make a decision about this additional distribution, would you please be kind enough to refer this request to the appropriate authority.
