

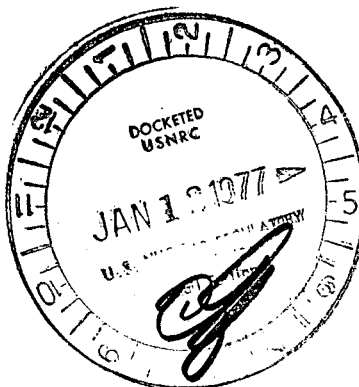

Please provide the following information or verify the information provided:

1. Nameplate Rating (Gross MWe) 887  
The nameplate rating is the megavolt amperage (MVA) times the nameplate power factor of the turbine-generator.
2. Maximum Dependable Capacity (Gross MWe) (1) 871 (2)  
The gross maximum dependable capacity is the gross electrical output as measured at the output terminals of the turbine-generator during the most restrictive seasonal conditions.
3. Design Electrical Rating (Net MWe) 887  
The net design electrical rating is that nominal output of the unit specified by the utility and used for the purpose of plant design.
4. Maximum Dependable Capacity (Net MWe) 871 (2)  
The net maximum dependable capacity is the gross electrical output as measured at the output terminals of the turbine-generator during the most restrictive seasonal conditions less the normal station service loads.

The above referenced information has been reviewed and corrected or verified.
