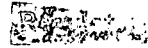

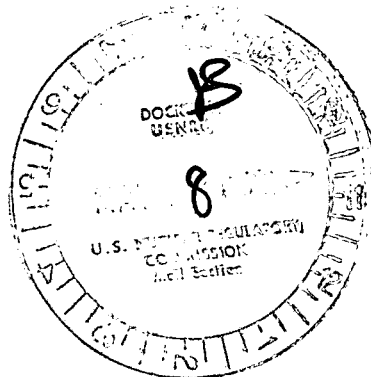
Dear Mr. Giambusso:
