
Dear Mr. Moseley:

On June 12, 1975, Duke Power Company submitted Supplement 1 to the Startup Report for Oconee Nuclear Station Unit 3. At that time, all or part of several power escalation tests remained to be completed.

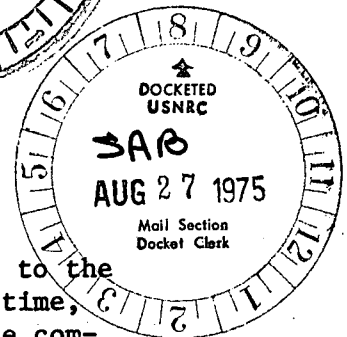
