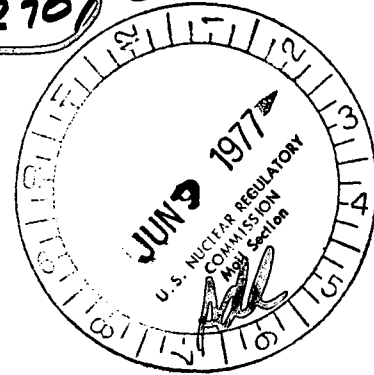

Return Premium: \$10,735.97


