Mr. Iten,

Thanks for confirming your email address.

I was at your facility on Tuesday, January 19 to inspect your license for distribution to persons exempt from licensing. I met with Richard Potts (?Terry?) who said that you were the RSO and not available, but that he was familiar with the program as the former RSO. I had already reviewed your annual reports, available in our electronic records system, and those were submitted annually as required since the last inspection.

I was able to look at one of the items during the inspection, and it was marked as required by the license commitments and regulations.

I also spoke to a person in Shipping/Receiving about how the item is shipped when it is transferred from your facility to its end user. He said that he just ships it, without any special package insert, statement, packaging, labeling or marking. He said that it was his understanding that there is not enough radioactive material in the item to require it to be shipped as a hazardous material. At the time of the last inspection in 2011, these items were shipped as UN2911 Class 7 material, excepted package, instruments and articles. Mr. Potts was not sure why this was changed, or which is correct. The person in shipping also said he is shipping the item as he was instructed, and does not know if other packaging or labeling is required.

Could you please let me know why you believe that the distributed item is no longer an UN2911 item, and not required to be shipped as radioactive material?
