Re: Amendment to License 07-28762-01 03032792

Dear Sir or Madam,

The purpose of this letter is to request an amendment to license 07-28762-01. In Agilent's license renewal letter dated September 5, 2015, we identified training requirements for the different functions handling licensed materials. Group 3, which represents personnel who ship packaged 15 millicurie Ni-63 Electron Capture Detectors (ECDs), but who have no exposure to open sources, was classified as requiring a "Review of ECD shipping requirements in area procedures."

Since submission of the license amendment, the business function responsible for shipping ECDs has changed its training format from a written procedure to a computer based training module (CBT). The CBT covers a variety of dangerous goods handled by the site in addition to radioactive materials. The portion regarding proper shipping of radioactive materials is consistent with the information previously contained in written procedures. The CBT also provides an improvement over the old process in that the employee is required to take and pass an on-line quiz in order to receive record of completion which was not required with a written procedure.

We request the description for Group 3 be amended by replacing the statement "Review of ECD shipping requirements in area procedures" by "Review of radioactive materials shipping requirements in a corporate approved Dangerous Goods computer based training module."
