I, David G. Wise, am the Radiation Safety Officer for this license (URS Energy & Construction) and our company is in the process of transitioning to System One, of which I am also an RSO for other Agreement State licenses. System One currently holds an NRC license # 37-27891-02 and we will perform radiography under that license for future work in non-agreement states.

License 12-31469-01 was only used at Licensed Nuclear Facilities for short term work and we possess no radioactive material under it as the manufacturer (QSA Global) stored material for us between jobs. No radioactive material shall be acquired and no work shall be performed under this license. I have been in contact with Craig Gordon at Region I as they previously handled our license and he has been of great help providing information for our transition.

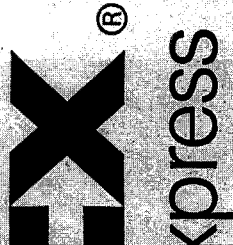

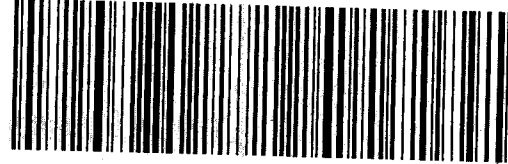

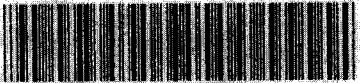
