

U.S. Nuclear Regulatory Commission Public Meeting Summary May 12, 2016

Title: Public Meeting and Teleconference to Provide an Update on Common Prioritization and Re-baselining of U.S. Nuclear Regulatory Commission (NRC) Activities (Project AIM Initiative)

Purpose of the Meeting(s): The purpose of the this meeting was to update stakeholders on Project Aim activities, particularly Common Prioritization and Re-baselining, since the September 1, 2015, public meeting to solicit input from stakeholders on the agency's work. This input assisted the agency in evaluating what activities can be shed (stopped), performed with fewer resources, or performed with a different priority, with little or no impact to the NRC's public health and safety mission and in a manner consistent with the NRC's Principles of Good Regulation and its Organizational Values.

General Details: The NRC conducted a public meeting beginning at 9:30 a.m. eastern standard time (EST) during which the NRC staff provided an update on Project Aim activities and responded to related questions. The meeting was attended by close to 80 participants on the phone and in person, with roughly half of the attendees in headquarters from the industry or non-government organizations.

Summary of Presentations: The NRC updated stakeholders on Project Aim activities, particularly how stakeholder input was considered during the recently completed Common Prioritization and Re-baselining effort. High level results were then shared, along with next steps.

The NRC responded to questions and comments about the transparency with which the agency has carried out this task, the meaning of terms such as "current and near-term" and "timely action," the timeline for process efficiencies going forward, and how stakeholders can be more involved with recommendations and decisions regarding this initiative. Some stakeholders suggested the NRC place more emphasis on task-oriented items rather than identify key processes for improvement, make an effort to incorporate the binning process into common prioritization of rulemaking, and consider the capacity to front-load Project Aim work to capitalize on the momentum of this initiative.

Actions/Next Steps: The NRC staff shared its plan to:

- Submit a notation vote paper regarding re-baselining by January 31, 2016, for the Commission's consideration.
- Prepare a list of long-term process improvements for efficiencies in Fiscal Year 2018 and beyond and projected changes in workload through 2020.
- Implement the Commission's decision on re-baselining.
