NOTICE OF CHANGE OF CONTROL

Please be advised that effective on or about April 1, 2016, Alpena Regional Medical Center, a Michigan municipal health facilities corporation ("ARMC"), will convert to a Michigan nonprofit corporation named MidMichigan Medical Center-Alpena, and MidMichigan Health ("MidMichigan") will become the sole member of ARMC. ARMC is a hospital in Alpena, Michigan and is the holder of the following Materials License:

Alpena Regional Medical Center, Materials License No. 21-17754-01

There are no plans to change the operations of the facility, and no personnel changes are anticipated at this time. There will be no changes in the location of the licensed facility, equipment, or procedures. The name of the facility will be changed to MidMichigan Medical Center-Alpena, as described above. All necessary surveillance of the facility has been performed, documented and reviewed prior to the consummation of this transaction.

All records will be transferred to the new ownership of the facility when the ownership of the entire facility transfers with an anticipated effective date of April 1, 2016. The records will stay in the same location and maintenance policies for all records will not change following the transaction.

The new owner of the facility, MidMichigan, commits to maintain all of the records received in accordance with all governmental requirements. MidMichigan agrees to abide by all constraints, license conditions, requirements, representations, and commitments in the currently issued materials license.

MidMichigan is not aware of any contamination of the facility or open inspection and enforcement issues disclosed to it by ARMC, and ARMC represents that it is not aware of any contamination of the facility or open inspection and enforcement issues associated with its.

Please consider this letter to be notice of the change in the ownership and name of the facility. It is our understanding that no further action on the part of the facility should be required

for your organization to issue its consent to the transfer of the license. 

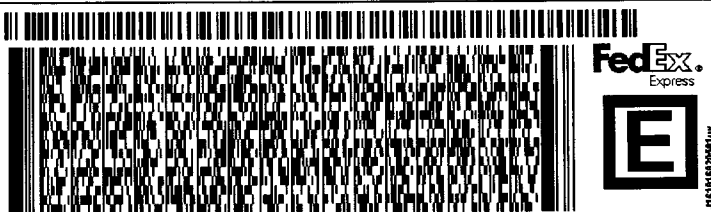
