SUBJECT: NOTIFICATION OF THE AVAILABILITY OF THE COMBINED LICENSE
APPLICATION FOR NORTH ANNA UNIT 3 IN ACCORDANCE WITH TITLE 10
OF THE *CODE OF FEDERAL REGULATIONS* 10 C.F.R. § 50.43

Dear Ms. Mount:

On November 26, 2007, Dominion Virginia Power (Dominion) tendered a combined license (COL) application to construct and operate an Economic Simplified Boiling-Water Reactor (ESBWR) at the North Anna Power Station site located in Louisa County, Virginia. The reactor is to be identified as North Anna Unit 3. The COL application is currently under review by the U. S. Nuclear Regulatory Commission (NRC) staff.

In that November 26, 2007, application, Dominion stated that it was submitting the COL application pursuant to the requirements of Title 10 of the *Code of Federal Regulations* (10 CFR) Part 52, "Licenses, Certifications, and Approvals for Nuclear Power Plants," Subpart C, "Combined Licenses," and requesting the associated materials licenses under 10 CFR Parts 30, 40, and 70. In addition, Dominion stated that the COL application incorporates by reference Revision 4 of the GE-Hitachi Nuclear Energy Americas, LLC application for the ESBWR Design Control Document (DCD) submitted on August 24, 2005. Since the initial submission of the COL application, Dominion has updated it to reference Revision 10 of the final ESBWR DCD application identified in NUREG-1966 and NUREG-1966, Supplement 1. The final rule for the ESBWR design is set forth in 10 CFR Part 52, Appendix E.

In accordance with the requirements found in 10 CFR 50.43(a)(1), the staff is providing this written notification to you because the staff has determined that your agency may have jurisdiction over the rates or services that are incident to the activity proposed in the Dominion COL application.
