Dear Mr. Lewandowski:

It has come to our attention that Amendment No. 49 to your NRC Material License No. 22-00057-61, issued on March 3, 2016, contained errors.

Condition No. 12.B. has been adjusted to clarify that the Alternate Radiation Safety Officer (ARSO) may act as RSO only in the **physical** absence of the RSO (emphasis added).

Condition No. 11.B. failed to include reference to your letter December 8, 2015 (with attachments) for training in the S-10 device.

Condition No. 19 contained a typo "S-15.8," instead of the correct "S-8."

These errors have been corrected.

We apologize for these errors and for any inconvenience they may have caused you.

Please also note that Condition No. 20 now contains accession numbers for our ADAMS document system. Original Amendment No. 49 included this change.


