NOTICE OF CHANGE OF CONTROL

Please be advised that effective on or about April 15, 2016, Oakland Physicians Medical Center, LLC d/b/a Pontiac General Hospital (f/k/a Doctors' Hospital of Michigan), a Michigan limited liability company ("OPMC"), will experience a change of control pursuant to a confirmed plan of reorganization in the bankruptcy case of OPMC, Case No. 15-51011, pending in the United States Bankruptcy Court for the Eastern District of Michigan. Under the reorganization plan, sixty percent (60%) of OPMC's membership interests will be issued to Sant Partners, LLC, twenty-five percent (25%) of its membership interests will be issued to Jawad Shah, M.D, and fifteen percent (15%) of the membership interests will be issued to Jolly Surindar, who is an existing member in OPMC (the "New Owners"). The equity in Sant Partners, LLC is 100% owned by Sanyam Sharma. After the closing, OPMC will be managed by a seven member board of managers initially consisting of the following individuals: Dr. Sanjay Sharma, Priyam Sharma, Sanyam Sharma, Surindar Jolly, M.D., Jawad Shah, M.D., Atif Bawahab, and Sudha Agarwal.

OPMC is a hospital in Pontiac, Michigan and is the holder of the following materials license:




