Dear Mr. Remley:

By letters dated February 28, 2014, September 26, 2014, March 31, 2015, and May 29, 2015 (Agencywide Documents Access and Management System Package Accession Nos. ML14062A070, ML14272A381, ML15090A618, and ML15149A307), Mitsubishi Electric Corporation (MELCO) submitted affidavits requesting that the information contained in the documents listed in the enclosure to this letter be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

Nonproprietary versions of documents, when submitted, can be found in the ADAMS packages referenced earlier.

MELCO detailed the reasons for withholding the information the affidavits.

The U.S. Nuclear Regulatory Commission (NRC) staff has reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, has determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the version(s) of the submitted information marked as proprietary will be withheld from public disclosure under 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, the agency may send copies of this information to its consultants working in this area. The NRC staff will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.

If the basis for withholding this information from public inspection should change in the future such that the information could then be made available for public inspection, you should promptly notify the NRC staff.
