SUBJECT: SUMMARY OF THE MARCH 2, 2016, CATEGORY 2 MEETING  
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION  
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On March 2, 2016, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association Standard 805 (NFPA 805). Licensees and the NRC staff discussed the list of currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

NRC staff announced the issuance of the closure memorandum for FAQ 14-0070, which is related to the use of untreated wood in the power block.

Industry stakeholders stated that a revision to FAQ 14-0071, which is related to the use of non-fire-rated cables, would be submitted prior to the next meeting.

NRC staff acknowledged receipt of revision 1 to FAQ 14-0073, which is related to the use of gasoline fired equipment, as well as the industry response to previous NRC staff comments. The NRC staff stated that there had not been enough time to consider the new revision before the meeting to support a detailed discussion, and the participants agreed to postpone discussion until the next meeting. The NRC staff stated that they expected to see proposed changes to the industry implementation guidance document (NEI 04-02), but that this did not appear to be present in the revision.

Nuclear Energy Institute (NEI) representatives briefly introduced a new FAQ (FAQ 16-0076) related to a process for updating Fire Probabilistic Risk Assessments used in NFPA 805 applications.

The NRC staff stated that a letter to NEI regarding staff expectations related to accelerating the review of changes to committed modifications and implementation items included in the plant's NFPA 805 transition license condition had been sent and was available to the public. NEI
