SUBJECT: PARTIAL APPROVAL OF NAC INTERNATIONAL INC. REQUEST FOR  
WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE OF  
PRESENTATION MATERIAL DATED DECEMBER 3, 2015, AND JANUARY 27,  
2016, RELATED TO MODEL NO. NAC-STC

Dear Mr. Fowler:

As part of the materials related to the partially closed meetings conducted on December 3, 2015, and January 27, 2016, related to the review of the Model No. NAC-STC transportation package, you submitted affidavits dated December 15, 2015, and January 29, 2016, respectively, requesting that the following information related to the Model No. NAC-STC package be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Part 2, Section 2.390:

Non-proprietary copies of these documents, as appropriate, were placed in the U.S. Nuclear Regulatory Commission's (NRC's) Public Document Room and added to the Agencywide Documents Access and Management System (ADAMS) Public Electronic Reading Room.

In general, the affidavits note that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- Information that discloses descriptions of the design and analysis of the NAC-STC radioactive material transportation packaging, where prevention of its use by competitors of NAC International Inc., without license from NAC International Inc., constitutes a competitive economic advantage over other companies.
- Information that, if used by a competitor, would reduce their expenditure of resources or improve their competitive position in the design, manufacture, shipment, installation, assurance of quality or licensing of a similar product.
- Information that includes certain portions of the safety analysis report, computer files, and documents containing calculations related to the design of the NAC-STC radioactive material transportation packaging, which are owned and are held in confidence by NAC International Inc.
- Information that NAC International Inc. "has invested a significant amount of time and money in the research, development, engineering, and analytical costs to develop the information. This information contains detailed descriptions of analytical approaches, methodologies, technical data, and/or evaluation results not available elsewhere."

We have reviewed your materials in accordance with the requirements of 10 CFR 2.390 and, on the basis of your statements, have determined that portions of the presentations at the partially closed meetings on December 3, 2015, and January 27, 2016, contain information publicly available (i.e., a summary of NRC's guidance) without clearly delineating the relationship of this information with the licensing approach proposed by NAC. This information includes the following:




