Dear Mr. Bergman:

In a March 14, 2016, letter, (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16074A434), Mr. Thomas Bergman, Vice President, Regulatory Affairs, requested that the following implementation plan be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- NuScale Power, LLC – "Human Factors Engineering Staffing and Qualifications Implementation Plan," RP-0914-8538-P, Revision 1, Proprietary Version (ADAMS Accession No. ML16074A435).

A non-proprietary copy of the implementation plan has been placed in the U.S. Nuclear Regulatory Commission (NRC) Public Document Room and added to ADAMS with the following ADAMS Accession No.:

- NuScale Power, LLC – "Human Factors Engineering Staffing and Qualifications Implementation Plan," RP-0914-8538-NP, Revision 1, Non-Proprietary Version (ADAMS Accession No. ML16074A434).

The affidavit in the March 14, 2016, letter (ADAMS Accession No. ML16074A434) stated that the submitted information should be considered exempt from mandatory public disclosure due to the proprietary nature of the information.

The NRC staff has reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
