INSTITUTE ON CONTROLLED UNCLASSIFIED INFORMATION  
POLICY AND THE SENSITIVE UNCLASSIFIED NON-SAFEGUARDS  
INFORMATION EVALUATION CRITERIA TO BE APPLIED FOR  
UPDATES TO THE FSARS, EP, AND FP DOCUMENTS (CAC  
NO. A11008)

On March 1, 2016, a Category 2 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC), representatives of Nuclear Energy Institute (NEI), and the industry at NRC Headquarters, One White Flint North, 11555 Rockville Pike, Rockville, Maryland. The purpose of the meeting was to discuss the Controlled Unclassified Information Policy and the sensitive unclassified non-safeguards information (SUNSI) evaluation criteria to be applied for updates to the final safety analysis reports (FSARs), emergency plan (EP) and fire protection (FP) documents, prior to releasing them to the public. The meeting notice and agenda, dated February 8, 2016, are available in the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML16050A021. A list of attendees is provided in the Enclosure.

The NRC staff presented the review criteria and the plan of action for the project managers (PMs) to use for the updated FSARs (UFSARs), EP and FP documents, before they are made publicly available (ADAMS Accession No. ML16071A016) and a discussion on the Controlled Unclassified Information (CUI) Policy. These presentations discussed the Commission's direction to the NRC staff to start making the UFSARs, EP and FP documents publicly available, the level of redactions the PMs will implement and a future policy change on the classification of documents.

NEI and the industry proposed the development of a mechanism to support feedback for those individuals performing the redactions, which could allow for increased consistency and efficiency. The industry questioned how to proceed should they be unable to submit the UFSAR electronically in its entirety. This is an ongoing issue for a few utilities. The NRC staff intends to discuss this with the Office of the Chief Information Officer to support resolution. Also, it is expected that as the Division of Operating Reactor Licensing (DORL) staff completes more of

these reviews, the criteria will be enhanced with additional insights and examples to further ensure consistency concerning SUNSI reviews of UFSARs.

NEI and the industry also discussed concerns about the CUI policy and if this was a matter of early implementation before approved rulemaking. The NRC staff assured NEI and the industry that this effort is separate from the CUI policy and it would be implemented later after the final rulemaking has been completed.

Members of the public were in attendance for the open session of the meeting. Public Meeting Feedback forms were sent out via e-mail upon request.
