Dear Mr. Hatten:

By letter dated December 10, 2015, Indiana University Health La Porte Hospital, Inc. d/b/a Indiana University Health La Porte Hospital submitted to the U. S. Nuclear Regulatory Commission (NRC) a Notification of Transfer of Control of NRC Materials License No. 13-15151-01. Based on the information provided, we understand that this is a direct change of control from Indiana University Health La Porte Hospital Inc. d/b/a Indiana University Health La Porte Hospital, an Indiana nonprofit Corporation to La Porte Hospital Company, LLC, a Delaware limited liability company. We further understand that as a result of this change of control, Indiana University Health La Porte Hospital will cease to exist and the name will change to La Porte Hospital Company, LLC d/b/a La Porte Hospital which will become the licensee for NRC License No. 13-15151-01.

Based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report which documents the NRC staff's review of the request, the NRC consents to the direct transfer of control. Amendment No. 51 showing the changes made to the NRC license is also enclosed.

The transferee, La Porte Hospital Company, LLC d/b/a La Porte Hospital should note their new responsibility and liability as an NRC licensee. Specifically, responsibility is emphasized with regard to any ongoing NRC inspection and enforcement issues, investigations, facility decontamination and decommissioning funding resources. Please be advised, change of ownership/control cannot be transferred without prior written consent from the NRC (10 CFR 30.34 (b)). 
