On March 17, 2016, the U.S. Nuclear Regulatory Commission (NRC) staff conducted the Reactor Oversight Process Monthly Public Meeting and communicated to stakeholders regarding the NRC's recent updates to the Enforcement Manual as they related to the continued use of the confirmatory action letter (CAL) process (Topic 2, Action 4). The staff did not believe the resource expenditure to support development of a Regulatory Issue Summary (RIS), as outlined in the action, was necessary given the non-controversial changes to the Enforcement Manual. Participants at the public meeting from industry agreed with this characterization and did not believe a RIS was warranted.
