The U.S. Nuclear Regulatory Commission (NRC) staff has reviewed amendment request dated February 18, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16068A396), regarding Triple, Inc. exempt distribution license no. 04-35240- 01E and Sealed Source and Device registration certificate NR-1412-D-101-E. The staff has determined that additional information is needed. In order to continue with our review, please address the issues listed in the enclosure.

A. REQUEST FOR ADDITIONAL INFORMATION REGARDING EXEMPT DISTRIBUTION LICENSE AND SEALED SOURCE AND DEVICE REGISTRAITON (SSD) CERTIFICATE

1. In your letter dated February 18, 2016, you stated that the new models, Sentry Chrono and 51-30 Chrono, are constructed of the same materials and the assembly process is the same as that of the Night Ranger T81. Besides the increase in the maximum activity for the new watch models, please describe the differences and similarities among all three models, preferably in a table format.

B. REQUEST FOR ADDITIONAL INFORMATION REGARDING EXEMPT DISTRIBUTION LICENSE

The following information is required by Title 10 of the *Code of Federal Regulations* (10 CFR) 32.22, "Self-Luminous Products containing Tritium, Krypton or Promethrium-147: Requirements for license to manufacture, process, produce, or initially transfer," and described in the relevant guidance document NUREG-1556 Volume 8 titled, "Program-Specific Guidance about Exempt Distribution Licenses."

1. In your letter you stated that each of the models (Sentry Chrono and 51-30 Chrono) will contain a nominal activity of 100 mCi of gaseous tritium in the form of sealed Gaseous Tritium Light Sources (GTLS). As required by 10 CFR 32.22(a)(2)(iv), please provide the solubility in water and body fluids of tritium gas.
2. As required by 10 CFR 32.22(a)(2)(viii), please provide the total quantity of byproduct material expected to be distributed in the product (including all models) annually.

C. REQUEST FOR ADDITIONAL INFORMATION REGARDING SEALED SOURCE AND DEVICE REGISTRATION CERTIFICATE

1. In your letter you provided drawings for the Sentry Chrono timepiece. The second drawing for the Sentry Chrono timepiece had dimensions that could not be read, specifically the dimension on the side view. Please resubmit a copy of the drawing, with readable dimensions. In addition, please ensure that all of the dimensions in the drawing include units of measure.
