By letter dated March 16, 2016, the Nuclear Regulatory Commission (NRC) staff notified Southern Nuclear Operating Company (SNC) of the final significance determination of the preliminary White finding discussed in NRC inspection Report 05000424, 425/2016-404 and a Notice of Violation associated with a White significance determination process (SDP) finding. The violation involved introduction of a contraband item into the Protected Area. SNC agrees with the NRC staff on the facts regarding the finding and, pursuant to the provisions of 10 CFR 2.201, submits its response to the violation as an Enclosure to this letter.
