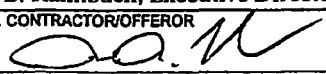
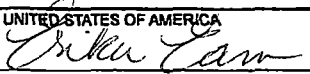
The purpose of this modification is to de-obligate excess funds and close out the task order. Therefore, the funded and ceiling amount is decreased to \$7,043.23.
