The purpose of this modification is to exercise OPTION PERIOD 6 (5/11/2016 - 5/10/2017), thereby extending the end date of the period of performance through May 10, 2017, and increasing the ordering ceiling by \$6,896,267.39, from \$49,340,058.66 to \$56,236,326.05.
