SUBJECT: SUMMARY OF APRIL 8, 2016, TELEPHONE CONFERENCE TO
DISCUSS TRIENNIAL DECOMMISSIONING COST ESTIMATE,
HONEYWELL METROPOLIS WORKS (COST ACTIVITY CODE
NUMBER L34349)

On April 8, 2016, the U.S. Nuclear Regulatory Commission (NRC) staff and representatives of Honeywell International (Honeywell or the licensee) held a telephone conference to discuss the staff's draft requests for additional information (D-RAIs) concerning Honeywell's proposed 2015 Decommissioning Cost Estimate (DCE) submittal dated January 6, 2016 (Agencywide Documents Access and Management System [ADAMS] Accession Number ML16008A088) for its Metropolis Works (MTW) facility.

As required by its Materials License, Number SUB-526, License Condition 25, Honeywell must submit an updated DCE for NRC review and approval at an interval not to exceed 3 years. Honeywell's January 6, 2016, DCE submittal updates its earlier DCE submittal provided on January 8, 2013 (ADAMS Accession Number ML13029A103), which was reviewed and approved by the NRC on July 23, 2013 (ADAMS Accession Number ML13191A901).

The telephone conference was useful in clarifying the intent of the staff's D-RAIs. Honeywell indicated that the D-RAI questions were clear. No decisions were made during the telephone conference, and Honeywell agreed that it would provide the information requested by the staff. During the telephone conference, the staff informed Honeywell representatives that the staff's D-RAIs, which were provided to the licensee by e-mail on February 25, 2016, would be issued as formal RAIs via a separate correspondence.
