This letter is in response to the request for additional information dated March 4, 2016 concerning an inspection identified within report number 03020243/2015002. A response to the Notice of Violation dated January 22, 2016 was provided by Mr. Donald Adkins on February 16, 2016. Apparently it was then determined by the NRC that additional information concerning actions to avoid recurrence relating to items B., C., and E contained within Mr. Adkins' letter. Consequentially, a response providing additional information was needed by April 4, 2016. This issue wasn't disclosed by persons directly involved in this process prior to their discontinuance of employment with the company therefore preventing a timely response. Information provided by this letter should allow closure of this issue.

Furmanite America, Inc. is now a Team Industrial Services company. The operations of Furmanite America, Inc. under its' NRC 47-23076-01 byproduct material license will be integrated into Team Industrial Services NRC license 42-32219-01. Actions to avoid recurrence concerning the issues noted above will be a result of these integration activities. Currently the 1200 Airport Road, Huntington, WV location is added to the Team Industrial Services 42-32219-01 license. All activities and materials formerly under license 47-23076-01 will be brought under the Team Industrial Services radiation safety and security program following training, certification and incorporation of program elements. A request to terminate license 47-23076-01 will be submitted upon completion materials and personnel transfer.
