By letter dated November 13, 2013 (Agencywide Documents Access and Management System Accession No. ML13323A100), Westinghouse Electric Company (Westinghouse) submitted for U.S. Nuclear Regulatory Commission (NRC) staff review Topical Report WCAP-17769-P, Revision 0, and WCAP-17769-NP, Revision 0, "Reference Fuel Design SVEA-96 Optima3" (Proprietary/Non-Proprietary). Upon review of the information provided, the NRC staff has determined that additional information is needed to complete the review.
