SUBJECT: SUMMARY OF THE APRIL 6, 2016, PUBLIC TELECONFERENCE  
MEETING WITH KOREA HYDRO AND NUCLEAR POWER CO. LTD. TO  
DISCUSS TOPICS RELATED TO CHAPTER 3 OF THE ADVANCED  
POWER REACTOR 1400 DESIGN CONTROL DOCUMENT

On April 6, 2016, a Category 1 public teleconference was held between the U.S. Nuclear Regulatory Commission (NRC) staff and Korea Hydro and Nuclear Power Co. Ltd. (KHNP). The meeting notice was issued and documented in the NRC Agencywide Documents Access and Management System (ADAMS) under Accession Number ML16028A052.

The purpose of the meeting was to discuss the schedule for and content of responses to the staff's Requests for Additional Information (RAIs) for items in Chapter 3 of the Advanced Power Reactor (APR) 1400 design certification document. A list of participants is included as Enclosure 1. Meeting handouts including the applicant's agenda, updated agenda and draft responses to RAI 8274, Question 03.08.04-3; RAI 8085, Question 03.08.01-4; RAI 8197, Question 03.07.02-4; RAI 8301, Question 03.07.03-3; RAI 8300, Question 03.07.01-5; RAI 8225, Question 03.08.02-2; and RAI 8285, Question 03.08.05-7; are available in ADAMS under package accession number ML16105A010.

With regard to RAI 8223, Question 03.08.01-13; the staff and applicant discussed the level of detail required in the DCD description of the prestressing system.
