SUBJECT: WITHHOLDING PROPRIETARY INFORMATION FROM PUBLIC
DISCLOSURE - SUBMITTAL OF ACCIDENT SOURCE TERM
METHODOLOGY REVISION 1 TOPICAL REPORT (PROJECT NO. 0769)

Dear Mr. Bergman:

In an April 8, 2016, letter, (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16099A394), Mr. Thomas A. Bergman, Vice President, Regulatory Affairs, requested that the following Topical Report (TR) be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

- NuScale Power, LLC – Enclosure 1, Topical Report, TR-0915-17565-P, “Accident Source Methodology,” Revision 1, Proprietary Version (ADAMS Accession No. ML16099A395).

A non-proprietary copy of the TR and the affidavit have been placed in the U.S. Nuclear Regulatory Commission (NRC) Public Document Room and added to ADAMS with the following ADAMS Accession No.:

- NuScale Power, LLC – Enclosure 2, Topical Report, TR-0915-17565, “Accident Source Term Methodology,” Revision 1, Non-Proprietary Version (ADAMS Accession No. ML16099A394).

The affidavit in the April 8, 2016, letter stated that the submitted information should be considered exempt from mandatory public disclosure due to the proprietary nature of the information.

The NRC staff has reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.

Withholding from public inspection shall not affect the right, if any, of persons properly and directly concerned to inspect the documents. If the need arises, the NRC staff may send copies of this information to our consultants working in this area. The NRC staff will, of course, ensure that the consultants have signed the appropriate agreements for handling proprietary information.
