Discussion: Mr. Sharawy called on April 11, 2016, and left a message asking for an update on the status of his license application. Monica Ford and I returned his call today and informed him that the application is still under review and that we needed additional information to complete the review.

I informed him that I would call him to discuss the items we still needed and follow-up the conversation with a written letter. Mr. Sharawy asked how long it would take. I informed him that I was unable to give a specific timeframe, but that completion of the review was largely dependent on him providing sufficient answers to our request for information. He then stated that he was curious because he sent the application in August of 2015 and he had not received his license yet. I told him I understood and that I would call him with the remaining questions we needed answered and follow up with a written letter. He stated that I do not need to call him, but rather that I should just send the letter and he would answer it within a day or two.
