Dear Mr. Larson:

On March, 24, 2016, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Beaver Valley Power Station, Units 1 and 2. On April 7, 2016, the NRC inspectors discussed results of this inspection with Mr. William Willis, Site Security Manager, and other members of your staff. Inspectors documented the results of this inspection in the enclosed inspection report.

NRC inspectors documented three findings of very low security significance (Green) and one unresolved item (URI) in this report. These findings involved violations of NRC requirements. The NRC is treating these violations as non-cited violations (NCV) consistent with Section 2.3.2.a of the Enforcement Policy.

If you contest these violations or the significance of these NCVs, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, DC 20555-0001; with copies to the Regional Administrator Region I; the Director, Office of Nuclear Security and Incident Response, the Director, Office of Enforcement, and the NRC resident inspector at the Beaver Valley Power Station, Units 1 and 2.

If you disagree with a cross-cutting aspect assignment in this report, you should provide a response within 30 days of the date of this inspection report, with the basis for your disagreement, to the Regional Administrator, Region I, the Director, Office of Nuclear Security and Incident Response and the NRC resident inspector at the Beaver Valley Power Station, Units 1 and 2.
