Dear Chairman Burns:

Thank you for your correspondence dated March 31, 2016, asking that I appoint a State Liaison Officer (SLO) to the Nuclear Regulatory Commission (NRC).

This letter will serve as notification that I am reappointing Mike Broderick as the SLO to the NRC for the state of Oklahoma. Mr. Broderick is the Oklahoma Department of Environmental Quality's Environmental Program Manager of the Radiation Management Section. He is in a position that affords him communication with my office and other state agencies in order to convey important and time-sensitive information provided by the NRC. Mr. Broderick is also able to keep your agency apprised of important regulatory, legislative and public interest issues as they occur within our state.

As SLO, Mr. Broderick will also function as my state employee representative, pursuant to § 73.59(e) of your regulations, for receipt of Safeguards Information (SGI) and Safeguards Information-Modified Handling (SGI-M) transmitted by the NRC. He has been informed of the protection requirements for SGI and SGI-M and will establish the controls necessary to maintain compliance with § 73.21 through § 73.23 of your regulations. His agency possesses the necessary physical protection resources for properly storing SGI and SGI-M.

I look forward to the continuation of meaningful communication between the NRC and the state of Oklahoma through the efforts of Mike Broderick and your regional state liaison officer.

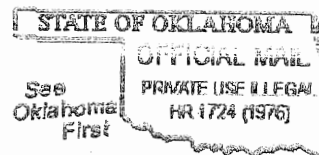
